I. Background

- 1. CPM-8 endorsed the strategy proposed by the CPM Bureau for taking registration of the ISPM 15 mark forward¹. The strategy has two stages:
 - 1) A five-year plan, which includes:
 - Sending a senior-level FAO letter to senior foreign affairs counterparts and permanent representatives in the countries with no registration.
 - Proceeding with the registration and renewal with funds allocated from FAO regular programme, encouraging the relevant countries to reimburse the cost.
 - 2) A long-term plan, which includes:
 - Requesting the SPG to develop longer term options and approaches with consideration of alternative funding mechanisms as well as other aspects.
- 2. CPM-8 also encouraged the contracting parties to work on registration and renewal.
- 3. The SPG (October 2013) noted the actions taken by the IPPC Secretariat and the FAO Legal office (at the time of the SPG, more than eighty countries were covered by the renewal actions, including those of the EU member countries and members of the Madrid system). The long-term plan will be developed in the next meeting of SPG.

II. Progress and Current Status

4. For all countries for which the initial registration expired in 2013, the renewal process has been completed. (Attachment 1 provides a listing of 198 countries and indicates their membership in IPPC, and whether or not the mark has been registered). Other relevant progress includes:

- Letters from the IPPC Secretariat were sent to IPPC contracting parties providing information
 on the reimbursement process in the event member countries wish to participate. A number of
 countries expressed their willingness to do so and the IPPC has already received some
 reimbursements.
- The Q&A information posted on the IPP².
- Prioritization for new registration began in early 2014.
- In order to assist NPPOs to receive proper support regarding the ISPM 15 symbol within the country, letters from the FAO have been sent to senior management in the relevant Ministry explaining the importance of this process and need for political and financial support.
- 5. The CPM is invited to:
 - 1) *note* the developments in regard to registration and renewal of the ISPM 15 symbol.
 - 2) *encourage* contracting parties to continue actively pursuing the process of national registration of the ISPM 15 symbol, including the renewal that are due to expire soon.
 - 3) *encourage* contracting parties to reimburse the Secretariat for renewal costs as soon as practically possible.
 - 4) *suggest* ideas regarding the long-term plan to be developed in the SPG.
