Project:	Validation of specified risk periods for regulated Asian Gypsy Moth (AGM) in countries of origin.

An EG member indicated that it was not realistic to have the project completed by July or August 2017 as outlined in the project workplan because</li> <li>More trapping data - particularly related to climate and dates- is needed, along with other supporting information</li> <li>With the recent changes in members in the AGM EG, time is needed for new members to review the existing information and provide any additional information</li> </ul>
