Project: General comments:	Develop a Science and Technology document that provides guidance related to contaminating pests on certified wood packaging material and wood commodities.				
	The NAPPO ED and TD welcomed and thanked the EG members for joining the videoconference. The ED and TD: • Indicated that the objective of the call is to address all comments provided to the Forestry S&T document 08 (Contaminating organisms affecting trade in wood commodities and forestry products) during the country consultation period. • Informed the EG members that "Country Consultation" comments will be addressed in two steps. First, EG members from Canada and the US will discuss all comments. When a consensus is reached on all comments, the NAPPO Secretariat will translate the document with all agreed upon changes into Spanish and share the document with EG members from Mexico. Second, a call will be scheduled with all the EG members from Canada, US, and Mexico to reach consensus with all three NAPPO countries and provide one more opportunity for feedback on the document. • Reminded EG members the videoconference was scheduled for 3 hours with a 15 min break. • Indicated that additional videoconferences could be scheduled pending the outcome of this call. • Indicated that comments in the document included those provided by Canada, the US and the NPPO of Argentina. • Informed the EG about the next steps once the country consultation comments were addressed and a consensus reached by the US/CA EG members.
