Summary				
Project:	Revision of NAPPO Regional Standard 8 (RSPM 8: Authorization of individuals to issue phytosanitary certificates)			
General comments:	The EG discussed the logistics of revising RSPM 8, an outline for the project's completion, and timelines. Logistics. The Technical Director stated that not all EG members have confirmed access to the EG Teams channel, a platform that will be used for collaborative work. Some experts requested that the link be resent. Revision work. RSPM 8 was last revised in 2013. The current revision work will focus on aligning RSPM 8 with IPPC ISPM 7 and 12, as well as aligning the terminology with that of ISPM 5 and RSPM 5. This will facilitate the identification of gaps and duplications in the RSPM. The work is expected to be completed within one year, as a revised draft must undergo a 60-day country consultation, incorporate additional discussions on the consultation comments, and receive final approval from the executive committee.			
	The ISPM 7 appendix is currently being developed. Stephanie Dubon (U.S. AMC member and IPPC Standard Committee member) will provide an update on the status of the specification.			
	The revision of the ISPM 12 specification is under public consultation and the project might be completed in 5-7 years.			
	Clarifying scope. ePhyto refers solely to cross-border XML schema transmission, not signatures or internal certification processes. The standard should prioritize ACO assessment regardless of whether it is on paper or electronic.
