### **Overall Objective**

- Purpose of the IYPH is to raise public awareness and support for plant protection services going into the next decade.

# Why is IYPH needed?

- Plant resources are coming under increasing pest pressure
- Future support and investment in plant protection services cannot be taken for granted
- The importance and value of plant protection need to be understood by the global community







#### **Objectives**

- Raise awareness among political decision makers at global, regional, and national levels about the importance of plant health.
- Strengthen national, regional, and global plant health efforts and resources in response to increased trade and new pest risks caused by climate change.

- 5. Increase information about the state of plant protection in the world.

#### IYPH must reach a broad audience


- Professional stakeholders, i.e. trade and grower associations
