Use of Systems Approaches in Managing Pest Risks Associated with the Movement of Forest Products

- Provides specific guidance on the combination of measures available to reduce the risk of pest infestation to support phytosanitary trade of wood commodities (round wood, sawn wood and wood chips)
- Describes measures which may be applied pre-harvest and during: harvest, transportation, production, export and post-shipping which may be integrated to address pest risks
- Describes the level of oversight and the specific duties of the NPPOs of the exporting and importing countries and other stakeholders
- Addresses diversity of commodities, number of entities involved from planting to harvest and the complexity of the production stream
